

«LIMITED WARRANTY FOR HJT PV MODULES»

This 《Limited Warranty for HJT PV Module》 applies only to Anhui Huasun Energy Co., Ltd (hereinafter referred to as "HUASUN") made Heterojunction (HJT) PV modules series (hereinafter referred to as "MODULES")

HS-S120SS、 HS-S132SS、 HS-S144SS、 HS-S156SS、 HS-B120DS、 HS-B132DS、 HS-B144DS、 HS-B156DS products.

1. Warranty Start Date

HUASUN warrants its MODULES performance to the original buyer (hereinafter referred to as "CUSTOMER") who purchase them directly from Huasun or Huasun authorized distributors for their own use, the warranty date starts from the date of sale with an Original copy of certifiable delivery and payment, or 6 months after the MODULES after being shipped from factory managed by HUNSUN, whichever comes first (hereafter short as the "WARRANTY START DATE").

2. Limited Product Warranty—Fifteen (15) Years Repair, Replacement or Refund Remedy

HUASUN warrants its MODULES to be free from defects in design, materials, and workmanship which influence MODULES performance under normal application, installation, use, and service (including repair) conditions as specified in HUASUN's standard technical documentation such as the installation manual. Material defects shall not include the effect of normal wear and tear.

If the MODULES failed to conform to this warranty within Fifteen (15) Years after the WARRANTY START DATE, HUASUN shall provide repair, replacement or refund the amount at the price of the MODULES when sale which needs to, minus the annual depreciation loss (The modules expected service life is 30 years with the 3.3% depreciation per year), after verified and confirmed in writing by an independent testing institution prior written selected and agreed by HUASUN and the CUSTOMER. The remedy of repair,

replacement or refund shall be the sole and exclusive measure provided under the "Limited Product Warranty" and is a unilateral decision by HUASUN and shall not be extended beyond the period set by warranty.

This "Limited Product Warranty" does not warrant a specific power output, which shall be exclusively covered by clause 3 as follows. ("Limited Performance Warranty").

3. Limited Performance Warranty—Thirty (30) Years Limited Compensation

The actual output power of the MODULES shall be measured under Standard Testing Conditions (STC). And the measurement is either carried out by HUASUN or by HUASUN prior written recognized third-party testing institute, which performed in accordance with IEC61215 as tested at the connectors or junction box terminals. STC are as follows: (a) 1000W/ m² irradiance, (b) Irradiance at the correct angle and the Module temperature is 25 °C (c) Spectrum amplitude AM 1.5.

HUASUN warranties that the modules output power will maintain a level of performance as below with 30 years starting with the warranty date:

- (i). During the first year, HUASUN warrants the actual power degradation of the MODULES will be less than 1%.
- (ii). From year 2 to year 15, the actual annual power average degradation will be no more than 0.37%; by the end of year 30, the actual power output will be no less than 88% of the Nominal Power output.

During the period of Thirty (30) Years from the WARRANTY START DATE, HUASUN can choose any ways to replace loss as below without the actual output power degradation caused by module quality defect.

- (a). Providing extra MODULES to the CUSTOMER to make up for power loss as above;
- (b). Replacing the defective module(s) or part by a functional equivalent;



The above-mentioned compensations in "Limited Performance Warranty" are the sole and exclusive remedy measure which will be unilaterally decided by HUASUN.

4. Limitation of Warranty Scope

Unless HUASUN agrees on and signs and recognizes other obligations and liabilities in written form, the warranty clauses in this 《Limited Warranty for HJT PV Module 》 will replace and exclude other explicit or implied assurances (including but not limited to the merchantability assurance, or assurance for special purposes、applications,) and other obligations and liabilities undertaken by HUASUN.

HUASUN is neither responsible for human injury or property losses nor for other losses or injuries caused by MODULES or MODULE-related problems (including but not limited to any module defect or any defect caused by use and installation).

HUASUN shall not compensate any collateral damages, derived damages, punitive damages or special damages and any other loss which were not occurred in real practice by any cause. Losses such as anticipated profit loss, production loss or revenue loss caused by product faults are excluded hereby. If HUASUN makes compensation for customers, the accumulated compensation amount shall not exceed the invoicing price for the defective module paid by the customer.

5. Obtaining Warranty Performance

CUSTOMER shall bear the burden of providing evidence for their own claim. If CUSTOMER believes there has been a breach of the Limited Product Warranty or Limited Performance Warranty (hereinafter referred to as "Warranties"), CUSTOMER shall promptly, and not later than thirty (30) days after knowledge thereof, notice HUASUN by sending an email letter to the public email account of HUASUN (sales@huasun.net) and setting forth the following information:

(a) party making claim; (b) detailed description; (c) evidence, including photographs and data; (d) relevant serial numbers; (e) Warranty Start Date; (f) Module type; (g) physical address; (h) clearly identifiable sales contract or proof of payment; (i) any additional

evidence reasonably requested by HUASUN; and (j) upon request from HUASUN, the actual Module(s) allegedly causing the breach.

HUASUN will not accept returned modules without the prior written return merchandise authorization. With the approval of the customer service department, the reasonable, normal, and proved shipping cost (including return cost and re-shipping cost of repaired and replaced modules) of modules related to "Limited Product Warranty" and "Limited Performance Warranty" shall be borne by HUASUB after checking and confirmation in writing.

6. Exclusions and Limitations

- (1) All warranty requests shall be submitted to HUASUN within but not beyond the warranty period in any case.
- (2) "Limited Product Warranty" and "Limited Performance Warranty" do not apply to any MODULES in situations below:
- (a) Improper use, misuse, negligence or accidents;
- (b) Fabrication without permission, impropinstallation, or application;
- (c) Fail to follow the HUASUN installation manual maintenance instructions;
- (d) Extreme thermal or environmental conditions, high density dust environment, or rapid changes in such conditions, not authorized by HUASUN:
- (e) Power failure surges, lightning, flood, fire, accidental breakage, improper connections resulting in hazardous reverse current or other events outside HUASUN control;
- (f) Modules which have been installed and energized on a permanent structure and later removed and re-installed on a different structure for energy harvest;
- (g) Repair or modifications by someone other than an approved service technician of HUASUN;
- (3) "Limited Product Warranty" and "Limited Performance Warranty" do not compensate costs as, any costs related to MODULE installation, demounting and re-installation (except for those stated in the last part of Section 5) or custom clearance costs, transportation costs and other costs related to return and replacement of modules.
- (4) Claims will be rejected if the MODULE model and serial number labels are falsified, removed or blurred

without written authorization by HUASUN.

7. Notice

Any notice required or permitted under this 《Limited Warranty for HJT PV Module 》 shall be in writing. Notices by email should be sent to sales@huasun.net. The customer shall promptly provide contact information in time for the request of HUASUN. For the avoidance of doubt, e-mail alone shall not constitute valid notice pursuant to this Section 7.

8. Severability of Clauses

If a part or a clause of the 《Limited Warranty for HJT PV Module》 is considered invalid or ineffective or not executable, or this part or clause to some people or some conditions is deemed invalid or ineffective or not executable, this situation shall not affect the effectiveness of other parts or clauses of the 《Limited Warranty for HJT PV Module》 . Therefore, the other parts or clauses in this 《Limited Warranty for HJT PV Module》 or the applicability of this 《Limited Warranty for HJT PV Module》 are considered independently effective.

9. Transferability

The clauses of this 《Limited Warranty for HJT PV Module》 will cover end users and can be transferred to any successive owners if the module's installation position is unchanged and the inheritance or transferring relations can be sufficiently proved, and in the case of this limited warranty, the remaining warranty period continues to be valid.

10. Dispute Resolution

If any dispute occurs with warranty claims and all the parties related reached an agreement to appoint an independent third party such as TÜV SUD, Intertek,

UL,CQC and CGC to make a technical appraisal. The application fee for appraisal shall be shared by all parties. If the conclusion is that Module has obvious defects and quality defects and in such case all the cost and fees shall be borne by the HUASUN, otherwise, it shall be borne by the CUSTOMER.

Any dispute arising from or in connection with this Contract shall be submitted to China International Economic and Trade Arbitration Commission for arbitration which shall be conducted ("CIETAC") in accordance with the CIETAC's arbitration rules in effect at the time of applying for arbitration. The place of arbitration shall be Shanghai, The People's Republic of China and the arbitration shall be conducted in the English language. The arbitral award shall be final and binding upon both parties. The arbitration fee shall be borne by the losing party.

11. Alteration

The repair, replacement or the provision of extra MODULES does not mean that the warranty period is renewed and the original warranty period of this 《Limited Warranty for HJT PV Module》 shall not extend. Any replaced MODULES are possessed by HUASUN and shall be treated or disposed of at its own discretion. In case HUASUN has stopped producing the same model as the defective MODULES is being claimed, HUASUN shall keep the right to provide the MODULES of other models (different sizes, color, shape or power).

12. Validity

This 《Limited Warranty for HJT PV Module》 is valid for all MODULES dispatched from HUASUN factories between 1st January 2021 and 31st December 2021. HUASUN is entitled to update and issue a new version of LIMITED WARRANT FOR HJT PV MODULES for Module pranticactured and shipped after January 1, 2022.
